"Troy in the English Historical Imagination."

Focusing on chronicles, heraldry, civic pageantry and Caxton's numerous translations of the Troy story, this study considers the position of Troy in latemedieval historiography.

"Gerard Legh's Accedens of Armory: A Critical Edition."

This is an edition of Legh's 1562 heraldry treatise. It began as a graduate course (Editing Premodern Texts) and the thirteen students will be listed as "Contributing Editors" in the published work.
