My Course Description

An overview of the impact of nutrition and exercise on selected health and exercise performance measures. Via lecture and reading materials, students will come to appreciate how lifestyle decisions which are under their control can enhance both health and exercise performance.

Learning Outcomes/Schedule:

Upon completion of this course, students will be able to:

- Recognize how factors largely under their control influence health and wellbeing
- Understand the importance of nutrition and exercise on both length and quality of life

- Discuss mechanism(s) responsible for optimal health
- Understand scientific method
- Interpret current research findings regarding the effects of nutrition and exercise on health and wellness

Required Course Material/Text:

No required text. All required readings will be posted on OWL.

Course Evaluation:

Assignments are due as stated in the course syllabus and will not be accepted late, except under medical or other compassionate circumstances. Submitting a late assignment without appropriate documentation will result in a zero (0) grade. Acceptable reasons include hospital stays, serious illness, family emergencies (like serious accidents, illness or death) or similar circumstances. Due to the size of this class, a makeup midterm quiz is not possible; therefore, if the midterm is missed and appropriate documentation is provided, the point value of the missed quiz will be added to the value of the research proposal assignment (see below).

Evaluation Dates (pending approval)

A. Midterm Quiz (via OWL) 20% - **Wed Feb 10, 2021**

B. "Hot Topic" Presentation (via Zoom, recorded and posted online) 15% - **choice of dates throughout term (selected during the first two weeks)**

Group (2-3 students) 10 *minute oral presentation of an exercise/nutrition topic of your choice (7 slides maximum; title slide, 5 data slides, references slide)*. Summary of topic to be made available for class viewing at least one day before talk. *All students will be prepared to ask questions of each presentation.*

C. Research Proposal (next logical experiment based on Hot Topic review w): 15% - **Fri, March 19, 2021**

Group (2-3 students) Research proposal of a current nutrition/exercise topic of your choice; format will include an introduction based on previous research, purpose/hypothesis, methods to be used, expected results, and several key references. This proposal is meant to extend the information learned from your hot topic presentation attempting to discover some novel information on the topic ((Limit: one page single spaced with key references on the back; do not include a cover page)

D. Final Exam (Comprehensive) 50% - **final exam period**

B) Computer marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating.

2. Electronic Device Usage:

Students who experience an extenuating circumstance (illness, injury, or other extenuating circumstance) sufficiently significant to temporarily render them unable to meet academic requirements may submit a request for academic consideration through the following routes:

- (i) Submitting a Self-Reported Absence (see below for conditions)

(ii) For medical absences exceeding 48 hours, submitting a Student Medical Certificate (SMC) signed by a licensed medical or mental health practitioner to their Academic Counselling in their Faculty of registration in order to be eligible for Academic Consideration; or
 (iii) For non-medical absences exceeding 48 hours, submitting appropriate documentation (e.g., obituary, police report, accident report, court order, etc.) to Academic Counselling in their Faculty of registration in order to be eligible for academic consideration. Students are encouraged to contact their Academic Counselling unit to clarify what documentation is appropriate.
 Students seeking academic consideration **must communicate with their instructors no later than 24 hours** after the end of the period covered by either the self-reported absence or SMC, or immediately upon their return following a documented absence.

The following conditions are in place for self-reporting of medical or extenuating circumstances:

- a. a maximum of two self-reported absences between September and April and one self-reported absence between May and August;
- b. any absences in excess of the number designated in clause a above will require students to present a Student Medical Certificate (SMC) or appropriate documentation supporting extenuating circumstances to the Academic Counselling unit in their Faculty of registration no later than two business days after the date specified for resuming responsibilities.
- c. The duration of the excused absence will be for a maximum of 48 hours from the time the Self-Reported Absence form is completed through the online portal, or from 8:30 am the following morning if the form is submitted after 4:30 pm;
- d. The duration of the excused absence will terminate prior to the end of the 48 hour period should the student undertake significant academic responsibilities (write a test, submit a paper) during that time;
- e. The duration of an excused absence will terminate at 8:30 am on the day following the last day of classes each semester regardless of how many days of absence have elapsed;
- f. Self-reported absences will not be allowed for scheduled final examinations; for midterm examinations scheduled during the December examination period; or for final lab examinations scheduled during the final week of term;
- g. Self-reporting may not be used for assessments (e.g. midterm exams, tests, reports, presentations, or essays) worth more than 30% of any given course;

For medical and non-medical absences that are not eligible for self-reporting Kinesiology students must submit an Academic Consideration Request form found online https://www.uwo.ca/fhs/kin/undergrad/files/accommodation_request.pdf in addition to an SMC or appropriate documentation in the event of a non-medical absence. These documents will be retained in the student's file, and will be held in confidence in accordance with the University's Official Student Record Information Privacy Policy.

6. **Grades:** Where possible assignment objectives and rubrics will be posted on OWL. Should you have a concern regarding the grade you received for an assignment or feel that it is unfair in any way, you must wait 24 hours from the receipt of the assignment to approach the instructor or TA. In doing so, please make an appointment and prepare in writing, with evidence, why you feel your grade is inappropriate. Please be aware that in requesting a grade reassessment, your grade could go up/down/or stay the same. Note that calculations errors (which do occur!) should be brought to my attention immediately.
