**ACTION OR PROCEDURE**

Assess and prepare equipment and chemicals	<ul style="list-style-type: none"> <li>a) Back injury</li> <li>b) Overexertion strain</li> <li>c) Slip, trip, fall</li> <li>d) Exposure to chemical</li> <li>e) Electrical contact/shock</li> </ul>	<ul style="list-style-type: none"> <li>a) Assess and inspect equipment, determine the appropriate equipment to be used. Electrical cords with G.F.C.I. protection is required. Report any damages or repairs.</li> <li>b) Mops and scrubbing equipment to be appropriate size by length and width and weight for area and surface type.</li> <li>c) Safely ensure footing and body position for awareness of slip trip or fall, ensure pedestrians safely aware of wet floor through use of wet floor signs at any corridor or common area effected. Restrict access to area as appropriate and post signage.</li> <li>d) Safely dispense chemical at disinfection dilution rate following manufacturer's guidelines, avoid spillage. See product labels. Wear goggles with use of spraying water or foaming agents to avoid contact with eyes.</li> <li>e) With any powered equipment, G.F.C.I. protection is required.</li> </ul>
Assign appropriate staff	Overexertion strain injuries	Re-instruct staff as required as to safe and ergonomic operation to avoid repetitive injuries if area is to be manually cleaned
Removal of large debris or obstacles	<ul style="list-style-type: none"> <li>a) Lacerations</li> <li>b) Exposure to bio hazardous surfaces</li> </ul>	<ul style="list-style-type: none"> <li>a) Wear gloves appropriate for removal of such debris</li> <li>b) Any bio-hazardous waste to be placed in double bag and disposed appropriately. Wear goggles, mask, and rubber/vinyl gloves while using antibacterial, anti fungal, germicidal solutions- refer to S. 20.</li> </ul>
Proceed with cleaning of shower area	<ul style="list-style-type: none"> <li>a) Over exertion strain injury</li> <li>b) Slip, trip, fall</li> </ul>	<ul style="list-style-type: none"> <li>a) Use appropriate method or equipment per application, appropriate size by weight, length and width area and surface type.</li> <li>b) Staff to watch proper footing and pedestrian traffic around them with caution to work environment awareness. Leave wet floor signs in position, use barriers and signage and if possible close area until floor is dry.</li> </ul>
