Introduction to Ethics and Value Theory

PREREQUISITE CHECKING

This course has no prerequisites.

COURSE DESCRIPTION

In this course, we will study the nature and justification of ethical and value judgements, the analysis of key moral concepts (duty and good), and a variety of contemporary ethical and value theories and their application to moral issues of social concern, for example, abortion, our treatment of non-human animals, and obligations to the global poor.

LEARNING OUTCOMES

By the end of the course, (assuming you have completed the readings and lessons, completed the assignments, and participated in the required activities/discussions) you should be able to:

- **Explain**, orally and in writing, multiple theories in normative ethics, metaethics, and value theory
- **Identify and evaluate** arguments expressing diverse points of view in normative ethics, metaethics, and value theory
- **Synthesize and consolidate** complex philosophical perspectives, arguments, and ideas in ethics and value theory
- **Construct** strong arguments in support of well-reasoned conclusions
- **Demonstrate respectful and charitable engagement** with different points of view on issues in ethics and value theory, even when they challenge or oppose your own perspective.

COURSE SCHEDULE

A detailed week-by-week schedule of readings and assignments, and a checklist to keep track, will be posted in Brightspace.

TEXTS

Assigned readings will include a combination of scholarly journal articles, book chapters, and other internet resources to be made available to you digitally **at no cost** through the course website in Brightspace. Some of the readings may require that you be logged into the Western Libraries system for access.

METHOD OF EVALUATION

The course grade will be based on participation in online small-group discussion, one midterm test, one digital project, and a final examination.

1. **Group discussion (10%)—weekly, throughout the term.** Each of you will be a member of a small group discussion board where you will be asked to start a discussion thread in at least five different weeks (in response to a question the instructor will post at the beginning of each week) and to participate in a co-member's thread in at least five different weeks. Which weeks you choose to take part are entirely up to you. The forum questions will be posted by Monday at noon each week and will remain open for new threads and comments on threads until the following Sunday at midnight. Recommended length per post (whether new thread or comment on someone else's): 150-250 words.
2. **Midterm Test (25%)—A 60-minute timed, online midterm that will be available for 24-hours from 9 a.m. February 25th to 9 a.m. February 26th, Eastern Time.** The midterm will consist of a mix of very short, short, and longer answer questions.
3. **Digital Media Project (25%)—Due Thursday, April 9 (submit before midnight).** A digital media philosophical project from among the following options: 10-minute video or video presentation; infographic; 10-minute audio podcast or audio presentation. Your project will require you to consider and respond to a philosophical question in a way that demonstrates your understanding of course content and your development of philosophical skills (such as exposition of philosophical texts; analysis of philosophical arguments; articulation and defence of a philosophical position in response to a question; consideration of an objection and reply). More detailed guidelines that outline the topics to choose from and the required components will be posted in Brightspace Assignments.
4. **Final Examination (40%).** A three-hour online examination to be scheduled during the official examination period (April 12-30). It will consist of a mix of very short, short, and longer answer questions. Further details about the final examination will be made available in late March. NOTE: the examination will be scheduled by the Office of the Registrar and could take place anytime between.
5. **Optional weekly online quizzes for self-assessment and consolidation of course material (0%).** These will be very short quizzes with a small number of questions (true/false; multiple choice; short answer) that help you to gauge and consolidate your learning from week to week. They are entirely optional and do not count towards your final grade.

STATEMENT ON THE USE OF GENERATIVE ARTIFICIAL INTELLIGENCE (AI)

Generative AI (such as, but not limited to, Chat GPT, Microsoft Co-Pilot, Google Gemini products, Anthropic's Claude products) are powerful and exciting, but their misuse will undermine academic values and learning outcomes of this course.

Prohibited uses and the rationale: Because this course aims to develop your philosophical skills of exposition, critical analysis and argument, creative thinking, and writing, you **may NOT use Generative AI tools for brainstorming or for drafting / writing any essays, assignments, test/exam answers, or discussion posts unless the assignment instructions specifically ask you to do so.**

Permitted uses: You may use AI tools for grammar-checking and spell-checking. If you do so, you must indicate that you have used AI in that way (as a footnote/endnote or part of your references), identify the tool, and retain the version of your paper that you ran through the tool for grammar and spell-checking.

If unauthorized use is suspected: Unauthorized use of AI will be treated as a scholastic offence and handled through Western's Scholastic Discipline Policy. In any case where your submitted work is suspected of such unauthorized use, the instructor will ask for research notes and/or drafts and outlines of assignments, and other materials used in preparing any assessments until after the assessment has been submitted. Students must keep all notes, outlines, and first drafts until after the release of final grades for the course.

Requests without supporting documentation are limited to one per term per course.
