Prerequisite: At least 60% in 1.0 Philosophy course at the 2000-2999 level, or permission of the department.

NOTE ON THE LEVEL OF THIS COURSE: No specific background in particular will be presupposed, but if this is your first honours-level philosophy course (or honours-level course is a cognate discipline, such as political science), and if the topic or political philosophy more generally is new to you, you may find it challenging.

COURSE DESCRIPTION

A survey of accounts of the foundations and limits of rights in property, from Aristotle to Marx. Other philosophers we will read include Grotius, Hobbes, Locke, Pufendorf and Kant. Questions we will ask include: Are rights in property natural or conventional? Should property be held privately or in common (or some combination)? What limits, if any, are placed on individuals' property rights by the temporary or enduring needs of others?

LEARNING OUTCOMES

Students who have done the readings, attended lectures, and (ideally, though this is not a formal requirement) participated in discussions in class will, by the completion of this course, have gained an understanding of a number of core issues in the history of property theory and some broader issues in the history of political philosophy, and will have developed skills in thinking critically and writing clearly.

TEXTS

All readings will be available, for free, on the course OWL page.

METHOD OF EVALUATION

One short (5 pp. handwritten) in-class essay, worth 25%.

One short (5 pp. double-spaced) essay written outside of class, worth 25%.

A short in-class test, worth 10%.

A final exam, worth 40%.

No form of AI (Chat GPT, etc.) may be used, at any stage, in the writing of your out-of-class essay. Students will be asked to sign a document attesting that they understand this, as a condition of your paper being graded, and may be asked to discuss their submitted written work.

ACADEMIC CONSIDERATION

Students may request academic consideration in cases of extenuating circumstances – that is, personal circumstances beyond the student’s control that have a substantial but temporary impact on the student’s ability to meet essential academic requirements.

1. Requests for academic consideration are made to the Academic Advising office of Faculty in which the student is registered.

2. Requests for academic consideration include the following components:
 - a. Self-attestation signed by the student;
 - b. Indication of the course(s) and assessment(s) relevant to the request;
 - c. Supporting documentation as relevant

Requests without supporting documentation are limited to one per term per course.

Documentation for medical illness, when required, includes the completion of a [Western Student Medical Certificate \(SMC\)](#) or, where that is not possible, equivalent documentation, by a health care practitioner. Requests linked to examinations scheduled by the Office of the Registrar during official examination periods as well as practice laboratory and performance tests typically scheduled in the last week of term always require formal supporting documentation.
