**NOTE ON THE LEVEL OF THIS COURSE:** This course will be cross-listed with a graduate seminar.

**COURSE DESCRIPTION**

A close look at the key elements and doctrines in Hume's moral and political philosophy. Hume was a very systematic philosopher, so we will begin at the beginning, with his general account of (as he said) human nature. We will also consider his famous sceptical account of causation. We will then work through his distinctive treatments of series of topics in moral and political philosophy: free will and determinism, virtue, duties, conventions, justice, property, contracts, and political authority. Most readings will be from his *Treatise of Human Nature*, but we will also read selections from both *Enquiries* and an essay or two.

**LEARNING OUTCOMES**

Students who have done the readings, attended seminars, and (ideally, though this is not a formal requirement) participated in discussions in class will, by the completion of this course, have gained an understanding of a number of key elements of Hume's moral and political philosophy, and will have developed skills in thinking critically and writing clearly.

**METHOD OF EVALUATION**

Three short (5 pp. double-spaced) essays and a final exam, each worth 25%.

No form of AI (Chat GPT, etc.) may be used, at any stage, in the writing of your essays. Students may be asked to sign a document attesting that they understand this, as a condition of your paper being graded, and may be asked to discuss their submitted written work.

### **ACADEMIC CONSIDERATION**

1. Requests for academic consideration are made to the Academic Advising office of Faculty in which the student is registered.
2. Requests for academic consideration include the following components:
  - a. Self-attestation signed by the student;
  - b. Indication of the course(s) and assessment(s) relevant to the request;
  - c. Supporting documentation as relevant

Requests without supporting documentation are limited to one per term per course.

Documentation for medical illness, when required, includes the completion of a [Western Student Medical Certificate \(SMC\)](#) or, where that is not possible, equivalent documentation, by a health care practitioner. Requests linked to examinations scheduled by the Office of the Registrar during official examination periods as well as practice laboratory and performance tests typically scheduled in the last week of term always require formal supporting documentation.
