S.06-98 Consideration for Admission of Candidates from Accredited Degree-Granting Institutions

The following statement will be added to the calendar for first and second-entry undergraduate programs. The purpose of the statement is to allow the University to consider candidates who come from degree-granting institutions where the issue of accreditation/recognition might be less than clear for various reasons. The statement gives Western the ability to consider such candidates for admission on an individual basis if their educational background is considered equivalent to that which we offer at Western and to the requirements of the program to which they are applying. It does not, however, guarantee admission which is always granted on a competitive basis.

Candidates with acceptable standing at accredited degree-granting institutions may be considered for admission provided that the content of studies completed is equivalent in content to the courses offered by Western, and to the requirements of the program to which the student has applied. The University will review other candidates on an individual basis. Admission in all cases is competitive.

S.06-99 **REPORT OF THE ACADEMIC COLLEAGUE** [Exhibit IV]

The report of the Academic Colleague on the 280th meeting of the Council of Ontario Universities, detailed in Exhibit IV, was received for information. Topics discussed at the meeting included: the Freedom of Information and Protection of Privacy Act (FIPPA) and reports from several

organizations including AUCC, the Ontario Commission on University Athletes (OCUA) and the Task Force on Quality Measurement.

Professor Carroll noted that FIPPA comes into effect June 10th and asked about the impact on faculty teaching summer courses, particularly with respect to posting grades and e-mail retention. Professor Doerksen advised that efforts are underway at the University to address ongoing requirements associated with compliance with the Act. He explained that the individual who made the presentation at the COU meeting had indicated that the Provincial Information and Privacy Commissioner's Office would likely not view posting assignment or exam grades by student number as appropriate because the student number is a unique identifier that falls within the definition of personal information in the Act. One possible option to deal with this could be for faculty to place the marks on WebCT.

With respect to keeping correspondence for one year, Professor Doerksen stated that a communication with a student that reflects an opinion on the student's work could fall within personal information in the Act. Mr. Keirstead, a member of the FOIP Advisory Committee clarified that the Act states that information that is used and acted upon must be kept for one year. Faculties and budget units have identified liaison officers who will be trained to prepare for the new legislation and will provide faculty and staff information about how to translate the legislative provisions to the academic environment. The government acknowledges that a transition period will be required for universities to adapt to the legislative requirements. Further information can be found at www.uwo.ca/privacy.

Federal Budget: New Support for Universities

- Post-secondary infrastructure trust:
 \$1 billion
 - Facilities renewal; possible \$26 m toward Western's capital plan
- Elimination of capital gains tax on gifts of securities
 - Leadership of Don Johnson
- Minister of Industry to prepare new Science and Technology Strategy

Federal Budget: Research

- \$40 million added for indirect costs, total envelope of \$300 million, rate now 27%
- · NSERC and CIHR: additional \$17 m each
- · SSHRC: additional \$6 million
- · Leaders Opportunity Fund of CFI: \$20 m
- Urgent need for longer term commitment to granting councils and CFI

Federal Budget: Student Aid

- \$500 tax credit for textbooks
- Scholarship/fellowship/bursary funds exempt from federal income tax
- Canada Student Loan Program made more accessible
- Transit-user tax credit (bus passes)

Provincial Government Relations Since May 2005 Ontario Budget

- Unfunded students: Western received first \$4.5 M of steady-state \$13.5M base increase
- Matching for OTSS (Ontario Trust for Student Support): Western received \$4.3M of \$6.5M provincial total
- · Special Accessibility Initiatives:
 - Aboriginal Access Initiative in Health Sciences: \$115,000
 - First generation access: \$100,000

Provincial Government Relations

- Accountability: Ministry will use appropriate performance indicators: NSSE, Graduate and Professional Student Survey, Student Retention Data Exchange
- Graduate Capacity: flexibility in Masters/PhD balance
- Student Aid: improving balance of provincial and institutional aid programs – Western test site
