S.07-157 **SUUPR Terms of Reference**

It was moved by T. Carmichael, seconded by P. Dean,

That the Terms of Reference of the Subcommittee on Undergraduate Program Reviews be revised to include a student member in the review committees for existing undergraduate academic programs, as shown below,

and

That the proposal be reviewed by SUUPR and SCAPA in two years time with the option to ratify or recommend changes to the Operations/Agenda Committee.

Existing Undergraduate Academic Programs

To ensure that existing academic programs are reviewed in the context of the Guidelines for Undergraduate Program Review according to a seven-year cycle of regular undergraduate program review for Constituent University and Affiliated University College undergraduate programs.

To oversee reviews of constituent University programs which require the preparation of specific program-focused documentation, including self-appraisal involving faculty and students, and a joint internal-external review by one or more external reviewers and a designated member of SUUPR.

To assign in this regard, to each program being reviewed, one faculty member of SUUPR (who shall not be a member of the unit being reviewed, but should be acquainted generally with the unit's operations) and one student member in Year 2 or above who is not enorlled in a program or module offered by the unit being reviewed (to be selected by SUUPR). The faculty members so assigned shall:

- participate in the undergraduate program review, making sure that full unit documentation, including a self-study involving the participation of faculty, staff and students, is provided to the reviewers, and that appropriate attention is paid to program structure and quality.
- 2) work with external reviewer(s) to ensure that all aspects of undergraduate programming are reflected in the reviewer's (s') report.
- 3) meet with the Chair/Director/Dean of the unit undergoing review and the external reviewer(s), as required.
- 4) once the external reviewers have prepared a report, and the Chair/Director and Dean of the unit being reviewed have responded to that report in writing, prepare a summary for SUUPR documenting the review process and assessing its responsiveness to the guidelines for the undergraduate program review.
- 5) present this summary, including specific recommendations, to SUUPR and amalgamate it into the annual report of the subcommittee.

three of whom conduct research involving humans,

one of whom does not conduct research involving humans,

One faculty member from an Affiliated University College, appointed in consultation with the Principal concerned on a rotational basis (two-year terms).

That Senate approve and recommend to the Board of Governors that Section Q of the *Appointment Procedures for Senior Academic and Administrative Officers* read as follows:

Q. VICE-PROVOST (GRADUATE STUDIES)

Composition of Selection Committee

A committee to select a Vice-Provost (Graduate Studies) shall consist of:

- (a) the Provost & Vice-President(Academic), who shall be Chair
- (b) the Vice-President (Research & International Relations)
- (c) 5 persons elected by Senate, one of whom shall be a Dean and one of whom shall be a Graduate Student

Procedure

- 1. The Chair shall convene the Committee.
- 2. The Chair shall undertake negotiations with prospective candidates.
- 3. The Chair shall report to Senate through the President & Vice-Chancellor.

<u>Terms</u>

The term for the *Vice-Provost* (*Graduate Studies*) is five years, renewable. In the case of renewal of an appointment where the incumbent takes a Study Leave at the end of the first term, the term of reappointment will be six years

Six Grade 12U or M courses including Grade 12U English, Biology, Chemistry, and Grade 11 Mathematics (MCF3M or MCR3U). Other applicants should consult the Registrar's Office at Brescia University College.

In addition, the official version will include corrections made at the June Senate meeting to references to Chemistry 1020 or 1023 in the Honors Specialization in Family Studies – BSc (Human Ecology) [page 9] and to Chemistry 1023 in the Specialization in Family Studies – BSc (Human Ecology) [page 10]. These have been revised to read "Chemistry 1050," the course that will replace Chemistry 1020 and 1023 in 2008.

That Senate receive and accept in principle, the *ad hoc* Committee Report on Graduate Education detailed in Exhibit IV, Appendix 1, and website: www.uwo.ca/pvp/vpacademic/gsreview.html

Professor Coulter expressed concern at the devolution of tasks to the faculties without the commitment of funds to support that increased workload. Dr. Longstaffe advised that funding was one of the transitional issues must be addressed. However, during the consultation process, it had become clear that much work is duplicated. Faculties asked for the ability at the program level to manage admissions and eligibility, thereby eliminating the duplication of effort and allowing them to move more quickly to secure the admission of good applicants. Dr. Longstaffe remarked that since 2005 when the Provincial government announced its program of significant investment in graduate education, approximately 130-140 faculty have been hired. Resources come from the University Priority Investment Fund which helps hire new faculty, the Enrolment Contingent Fund which takes into account the numbers of both undergraduate and graduate students, and the Graduate Education Fund which funds incremental growth in graduate students and a top up from the GF Plus fund. Approximately 85% of the new funding received for the incremental graduate students flows back to the programs. During the upcoming budget and planning process the Deans will be asked to identify resource implications associated with this initiative.

The motion was called and CARRIED.

Nabisco Brands Incorporated, for whom this Professorship was originally named, no longer exists as a legal entity and has been taken over by Kraft Canada.
