**NOTE:** Conditions of Appointment: Clinical Departments, Faculty of Medicine -- the University of Western Ontario and Affiliated Hospitals and Institutions (1988) still applies in the case of basic scientists in clinical departments who are not members of the UWOFA bargaining unit. Under this document, the ultimate stage of grievance is the Senate Grievance Committee. It is expected that a new document concerning the appointment of basic scientists in clinical departments will be presented to Senate later this year. Once that is in place, the Senate Grievance Committee will be disbanded.

**Composition:** The panel from which members are selected by lot is composed of nine **tenured** members of the faculty of the constituent University, elected by Senate. At least one member of this panel but not more than two shall be from each of the Faculties of Arts, Science, Social Science and Medicine & Dentistry, and not more than one shall be from any other Faculty.
